This has reference to the proposal submitted by Hindusthan College of Engineering and Technology, Tamilnadu affiliated to Anna University, Chennai for extension of Autonomous Status.

The Commission at its meeting held on 26.05.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to extend the autonomous status to **Hindusthan College of Engineering and Technology, Tamilnadu affiliated to Anna University, Chennai** for a period of 10 years from the academic year 2022-2023 to 2031-2032 as per clause 8.2 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University, is therefore, requested to issue necessary notification within 30 days regarding the Extension of autonomous status to the College as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.gov.in. Non compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023. The college should apply to University Grants Commission for extension of autonomous status atleast three months before the completion of autonomy period.

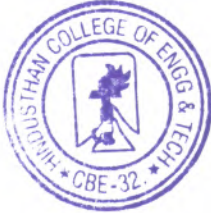
Dear Madam/Sir,

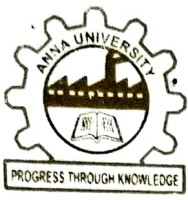


